LOCATION

The subjects are located in Scalasaig, the main settlement and ferry port on the island of Colonsay. Scalasaid is a popular tourist destination on the island, anyone visiting the island will pass through the main ferry terminal.

Colonsay is an island of approximately 40km circumference, famous for being the world's smallest island to have two independant distilleries producing award-winning gins.

The island is accessible from the port of Oban which is approximately 2 hours' drive from Glasgow and 3 hours from Edinburgh. There is a regular Caledonian MacBrayne car ferry service from Oban to Colonsay which takes 2 hours approximately.

Local business on the island includes oyster farming, fishing, hospitality, retail, publishing and tourism services.

DESCRIPTION

The subjects are located on the ground floor of a single storey building of block construction, surmounted by a pitched tiled roof.

Internally, the property is split into two separate areas including a retail section previously used as a bookstore and a warehouse/workshop area previously used for publishing and distribution. Toilet facilities and a tea prep area are located to the rear.

Access is through a single door entry with large roller shutters to the side. There is large display signage at the rear of the premises visible to the ferry port and local road network.

ACCOMODATION

According to our calculations, the subjects have a total Gross Internal Area of 80.55 sq.m. (867sq.ft.) approximately.


